

Article 1. These Regulations prescribe essential matters in relation to the use of the supercomputer systems of the Inter-university services and general-purpose computer systems (hereafter the “Large-scale computer systems”) managed and operated by Academic Center for Computing and Media Studies, Kyoto University (hereafter the “Center”).

Article 2. The Large-scale computer systems may be used for purposes including academic research and education.

Article 3. The Large-scale computer systems may be used by the following categories of people.

- (1) Academic staff members of universities, junior colleges, higher colleges of technology and inter-university research institute, and those equivalent thereto
- (2) Graduate school students and those equivalent thereto
- (3) Persons engaged exclusively in research and affiliated with institutions operated by a national or local government authority for the purpose of academic research
- (4) Persons engaged in academic research funded by the Grants-in-Aid for Scientific Research program
- (5) Other persons authorized by the Director of the Center

Article 4. Those wishing to use the Large-scale computer systems must submit the specified application form to the Director of the Center and receive authorization.

2. The Director of the Center shall issue user ID to those authorized to use the Large-scale computer systems (hereafter “Users”) and notify them accordingly.

Article 5. Users must report the results of usages associated with their user ID to the Director of the Center at the end of the fiscal year.

2. The Director of the Center may require Users to provide reports on their use on occasions other than those stipulated in the preceding paragraph.

Article 6. When publishing papers and other outputs on the results of research using the Large-scale computer systems, Users must clearly state in such outputs that they have used the Center.

Article 7. Users and/or their proxies must bear a Large-scale computer systems usage fee as a contribution to the costs of their use.

2. The amounts and methods of defrayment of Large-scale computer systems usage fee shall be prescribed separately by the President.

Article 8. Users must promptly report to the Director of the Center and/or re-apply, as separately prescribed by the Director of the Center, if they wish to alter any details provided in the application form or when there is any change in such details.

Article 9. Users must report promptly to the Director of the Center if they damage any of the Center’s devices or other facilities, or lose or damage any printed matter.

2. The Director of the Center may require compensation from those causing damage or loss.

Article 10. The Director of the Center may revoke approval of use of the Large-scale computer systems or suspend use for a designated period for any User who contravenes these Regulations or other rules made pursuant to them, or otherwise significantly obstructs the operation of the Center.

Article 11. The Director of the Center shall prescribe any essential matters in relation to the use of the Center that are not prescribed in these Regulations.

Supplementary Provisions

1. These Regulations take effect on April 2, 2002, and apply from April 1, 2002.
2. The following regulations are hereby abolished.
 - (1) Kyoto University Regulations for Use of the Data Processing Center (Order No. 22, 1969)
 - (2) Kyoto University Regulations for Use of the Center for Information and Multimedia Studies (Order No. 2, 1998)
3. Persons granted approval pursuant to the Kyoto University Regulations for Use of the Data Processing Center for use in the 2002 academic year prior to these Regulations coming into effect shall be deemed approved pursuant to these Regulations.
4. Persons granted approval for use pursuant to the Kyoto University Regulations for Use of the Center for Information and Multimedia Studies prior to these Regulations coming into effect shall be deemed approved pursuant to these Regulations.
